According to UGC guidelines all Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the purview of a Public Authority under this Act. Since Sainath Education Trust's, Rajiv Gandhi College of Arts, Commerce & Science, Vashi, Navi Mumbai is "Self Financing" category, Section 4(1) (b) of RTI Act 2005 is applicable for college. Full text of the act is available on the website <https://rti.gov.in/>. Our college is a "College of co-education" which is registered under society act by Govt. of Maharashtra. The College has a Governing Body which runs as per rules and regulations made by the Govt. of Maharashtra from time to time. All the cells or committees of the institution are under Statutory Bodies and comes under section 4(1) (b) of RTI Act 2005. The applications under the RTI Act along with a postal order/demand draft for Rs.10/- obtained in favour of Rajiv Gandhi College of Arts, Commerce & Science, may be sent to the Public Information Officer (PIO) or handed over in his office.
