Clarification on Minority Status and Admission Policy

We would like to provide clarification regarding our Institution's Minority status and admission policy at Sainath Education Trust's, Rajiv Gandhi College of Arts, Commerce, and Science, Vashi, Navi Mumbai.

Our college was established in 2002, and our Trust were granted Hindi Linguistic Minority Institution status from 09th February 2009, in accordance with Government Regulations. This status is confirmed by the Supreme Court's verdict, which clearly states that Minority institutions are not obliged to reserve seats for students belonging to reserved categories. NAAC data template does' not accept 0 seats earmarked for reserve category students but as per rule we don't have any seats earmarked.

In compliance with the regulatory requirements, we have attached the original Minority letter in Marathi, as well as its translated version in English, for your reference. These documents validate our minority status and reiterate the absence of reservation quotas for specific student categories within our institution. We also attaching order As per judgment dated 12th Oct 2017 by the Hon'ble High Court, Bombay in writ Petition 1726 / 2001 in the matter of St. Xavier's College and Maharashtra Association of Minority Education Institution v/s Mumbai University and State of Maharashtra regarding Minority Institutions along with University of
