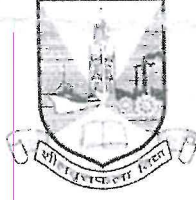

- 5) That they will not start any division/subject/course without the permission of Government/ University.
- 6) That they will comply with the conditions laid down by Government with respect to admission of students belonging to Scheduled Cast, Scheduled Tribes, Denotified Tribes, Nomadic Tribes and Other Backward Classes.

- (2) to fulfill the conditions laid down by the University from time to time.
- (3) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- (4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987 dated 4th February, 1987 (copy enclosed).

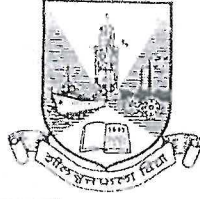

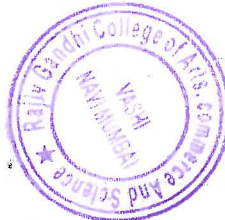
